Your Privacy

The information you provide on this form may be stored electronically and will be used for the purpose of processing your application. The information may be shared with Hertfordshire County Council, who may from time to time send you advice, guidance, and information relating to changes to early year provision and educational services relevant to your child, and who may share this information with the local children's centre who support the local authority by assisting families to access the service that children are entitled to.
